# **TERMS AND CONDITIONS**

We advise that you carefully read these terms and conditions before you access or use our app. The following terms govern the use of the 3Way app, and the content and services available on or through the app. The app is owned and operated by Made By Ayman, LLC, and we offer its use conditional to your acceptance of all of the terms and conditions herein contained.

If you do not agree with any or all the conditions of this agreement, please desist from using this app.

We may review/revise these terms and conditions at any time we deem fit and without prior notice to you. We will take your use of the 3Way app after any such change as your continued agreement to be bound by the terms as changed. We will indicate last date updated at the top of this page every time we revise/review our terms.

# **OUR SERVICE OFFERING**

We offer the app as a platform for users to anonymously connect two people in a phone call. For example, users may initiate a phone call with their best friend and his ex or to connect two competing pizza shops, and are able to listen to the recorded conversation after the phone call is over. Users have the choice of telling the recipient of the calls afterwards or may choose not to.

## **PERSONAL USE ONLY**

We provide the 3Way service for personal entertainment purposes only. This means that you are only allowed to use the service in a personal and noncommercial manner.

#### **AGE 18 AND ABOVE**

The 3Way app is intended for persons who have attained the legal age of 18 and are able to form and enter into legally binding contracts according to the law of the United States.

# **REGISTRATION AND ACCOUNT INFORMATION**

While visitors are welcome to browse through our app, you may be asked to fill a form to be able to gain access to some parts of our app and to use our prank calling service. This may require that you supply personal information such as your name, country of residence, email address, phone number, and other information that we may require. This is optional. Alternatively, you can log in to the service with your Apple ID.

You hereby represent that the information you provide on 3Way at any given time is truthful, comprehensive, and not misleading. We may refuse you service if the information provided is found to be false, incorrect, or deliberately misleading.

Once registered, you will have access to an active personal 3Way user account and are expected to keep your account information secure. All activities connected with your account are your sole responsibility, and you hereby agree to maintain the safety and confidentiality of your account details at all times.

You may only register and use one 3Way account and must notify us immediately if you believe a third party has accessed your account without authorization.

# LICENSE/ACCEPTABLE USE

We grant all eligible users a limited, revocable, nonexclusive, nonassignable, nonsublicensable license to access and use the app in compliance with these terms and conditions.

## **PAYMENT OF PURCHASED SERVICES**

We make most of the 3Way's features and/or service available to users for free, but we do not guarantee that all segments of such features and/or services will always be so available for free. This means that we may occasionally request you to purchase or undertake certain activities in order to continue to access that portion of 3Way's services.

Anytime you make any purchase through 3Way, you represent that you will pay all applicable fees for those purchases, in accordance with the specific terms for that service/features purchase.

# ALL PRICES ARE STATED IN U.S. DOLLARS.

You also accept that we do not give refunds for any service paid for, whether the request for refund is made on the premises of dissatisfaction, lack of usage, as well as for the discontinuation of any 3Way's service or functionality or not.

## **RECORDING OF CONVERSATIONS**

You accept that 3Way may record the telephone calls placed through it. According to the applicable international, national, state, and local laws or regulation in force in certain jurisdictions, telephone conversations can be recorded if one party to the conversation agrees to the recording.

In some jurisdictions, however, the law does not allow telephone conversations to be recorded except all parties to the call are aware of and consent to the recording. You therefore represent and warrant that you consent to the recording of any telephone calls that you initiate through 3Way and that you do this in compliance with the laws applicable to the recording of the telephone conversations where you and your call recipients are located.

#### **PROHIBITED USES OF 3WAY**

The prohibited uses of 3Way include:

Using 3Way to call any service for which the called party is responsible for the call fees, except the call is made with the prior consent of the called party;

Transmitting or attempting to transmit any worms or viruses or other codes of a destructive nature through our network, and/or sending any junk email to other users;

Using the service for any illegal or unauthorized purpose, and/or violating or attempting to disrupt the security of the app;

Violating any laws in your jurisdiction in the course of your use of this app and/or acting in a way that infringes or violates other people's rights;

Using the app to spread content that encourages racist and/or criminal offences, and/or using the service to promote other apps, services or businesses;
